MARTA Police Holiday Safety Initiative

As terrorist attacks and threats around the world increase, the U.S. Department of Homeland Security is requiring all transportation agencies across the country to take more protective measures to secure and fortify their systems.

In response to this requirement, MARTA will:

- Increase Protective Specialist patrols at MARTA HQ and the Annex building
- Continue to conduct random Target Hardening Operational Response (THOR) on trains and buses
- Pass out awareness flyers to customers
- Monitor all special events and add extra staffing when needed
- Monitor any MARTA system crime trends
- Monitor crime trends of jurisdictions that are close to the MARTA system
- Monitor CCTV in real time
- Monitor events that take place in the U.S. and around the world

\$75M Bond Program

The Georgia Legislature allocated \$75M in State bond funds for transit capital project.

Eligible applicants include:

- Existing public transportation operators that are governmental units
- Local, regional, state government units; and
- Community Improvements Districts (CIDs)

Additional key rules:

- No applicant may receive more than \$37.5M
- Projects in progress may be submitted to fund phases not yet complete
- No local match required
- Applicants providing more total match will be given greater consideration
- Providing Georgia jobs not a requirement, but likely to be viewed favorably Leading MARTA Candidate Project:
 - Rail station public address and signage system (AVIS). This project will improve safety and State of Good Repair while enhancing accessibility, connectivity and system integration. A local match of 20%+ will be provided

Amendment to Resolution Approving the Disposal of Parcel D3191 at Canterbury Road in the City of Atlanta

Resolution Authorizing the Award of a Contract for the General Counsel and Other Legal Services Contract, RFP P36180

The Board of Directors received a briefing outling the proposal process in seeking a new General Counsel and Other Legal Services contract. The contract term will be five years for a value not to exceed twelve million dollars.
