GEC Transition Plan

The Board received an update on the third installment of the GEC Transition Plan.

Challenges include:

- Aging infrastructure & systems
- Constrained revenue stream, reduced ridership, etc.
- Under executing CIP (debt service)
- High soft costs, less product being delivered
- Dependency on external consultants not sustainable

Solutions.

- Develop an executable plan
- Prioritizing agency needs
- Right-size internal and external resources
- Reduce cost of delivery of services

Essential Next Steps.

- 1. Exercise option years three, four and five of the GEC contract to allow for continued (essential) services through FY 17
- 2. Finalize schedule and secure A&E Services Contracts that were approved for advertisement by the MARTA Board no later than FY 15 Qtr4
- 3. Fill vacant technical positions within Engineering & Development (E&D) and Program & Contract Management (P&CM)
- 4. Approve hiring of Direct Contractors without a vacancy constraint
- 5. Approve continuation of GSA contractors (GCPS renewal)
- 6. Right-size agency administrative staff to manage contracts

<u>Legislative Update – R. Briggins</u>

Three bills have been introduced for the start of a study committee:

- SR 1027 Brandon Beach T-SPLOST
- SR 1064 Steve Gooch Transportation infrastructure funding
- HB 1573 Transportation infrastructure funding
- HB1009 Clayton County bill will enable Clayton County to join MARTA, contract out or run their own system.
- HB 264, 265 MARTA placed legislative items in the bill. The first hearing was held two weeks ago. The bill was tabled.

MARTA Transformation Initiative

MARTA's Board of Directors endorsed the "transformation Road Map" in February 2013. The Road Map contains twelve specific initiatives arising from the KPMG Management Audit. These initiatives are being addressed to move the Authority to a more sound foundation that insures the agency's long-term viability and insures that public transit remains a vital part of the metropolitan Atlanta community. These initiatives comprise a 5-year program of transformation that is managed by the Transformation Program Management Office (PMO).

TOD Development and Real Estate Update

MARTA's overarching strategic goals for Transit Oriented Development include:

- Generate greater transit ridership a natural consequence of clustering mixed-use development around stations and along corridors;
- Promote a sustainable, affordable and growing future for the people of Metro Atlanta; and
- Generate a return on MARTA's transit investment through enhanced passenger revenues, greater federal support and development on MARTA property.

- Medical Center Station
- Dunwoody Station
- New Stadium Project Timeline and Proposed Activity
- New Stadium Project: Vine City Station

- Retail and Concessions psychographic analysis, retail evaluation and financial opportunity study update has been finalized
- Real Estate RFP for real estate brokerage services
