 A chargeback is when a credit card company refunds money after a customer successfully disputes the transaction charge on his credit card statement

MARTA determined that most chargebacks were the result of fraudulent activity. To reduce the risk of fraudulent transactions and chargebacks, MARTA implemented zip code verification on the Breeze Vending Machines and 3-digit security code verification on all internet sales.
