### **Public Comment**

Mr. Taylor addressed the Board regarding his concerns: closed restrooms, urine in elevators, aggressive panhandling, lights out, bad track section, infrequent trains, crime, and no staff at Airport Station.

Mr. Dallas asked that MARTA embrace the KPMG audit in order to move forward and not to look at MARTOC as an advisory. This will achieve an important goal – trust.

Mr. Beasley expressed concern regarding reports he read in The Atlanta Journal Constitution. He asked the MARTA Board to remember who they are and not let others dictate who the next CEO should be.

Senator Fort stated he did not support legislation last session which gave Fulton County mayors appointments to the MARTA Board. It was not right to have MARTA lobbyists lobbying for that bill. There has been discussion about privatizing. There has been a constant drumbeat about MARTA being insufficient. The facts do not bear this out. The first criterion for a General Manager is not being a lap dog to the Governor or the Legislature.
