General Manager/CEO Report

- MARTA experienced a very successful SEC Championship game.
 MARTA continues to deploy a substantial number of staff during these special events. Mr. Parker thanked staff (police, operations and administrative) for volunteering to come out and deliver exceptional customer service
- The MLS Championship game will be held this weekend. MARTA will again deploy police, operational and administrative staff
- The Authority is finalizing the schedule for extended service for the Super Bowl. A final update will be presented to the Board during the January meeting
- On this past Saturday, MARTA was present for the Children's Hospital of Atlanta parade. Approximately 40 MARTA employees gave out candy
- Union negotiations continue and are progressing well. The Union have asked for a couple days of negotiation during January.

Chairman Ashe asked about improvements to restroom accessibility in the stations. He asked for an update.

Mr. Parker said a new policy has been implemented. The stations that have traditionally had open restrooms (approximately 12), now have extended hours until 10:30 p.m. MARTA is also working on a program whereby access to restrooms is available throughout the day

Mr. Parker said moving forward, a quarterly report will be delivered to the Board.
